Food Bank of Central & Eastern North Carolina Gears Up for TEFAP Distribution in Person County

RALEIGH, NC - The Food Bank of Central & Eastern North Carolina, one of seven Feeding America member food banks in North Carolina, will distribute The Emergency Food Assistance Program (TEFAP) government commodities in Roxboro from 11 a.m. to 2 p.m. on Thursday, December 19. The distribution will be held in the parking lot beside Christian Help Center, located at 122 Depot Street in Roxboro. The Food Bank will hand out roughly 400 boxes of food during the distribution.

TEFAP is the Federal commodities program that helps to provide food assistance to low-income households. In North Carolina, individuals and families whose incomes are at or below 200 percent of the Federal Poverty Guideline qualify to receive TEFAP commodities. For example, a family of four that earns \$47,112, or less each year qualifies to receive TEFAP commodities. Any household that receives Food and Nutrition Services (i.e. FNS, formerly known as Food Stamps) benefits automatically qualifies to receive TEFAP commodities. Families do not have to prove their household incomes or FNS participation to receive commodities. Families self-declare their eligibility for the program.

Commodities will be available on December 19 on a first-come, first-serve basis.
